- Staff #1 "Support Staff Overtime" - Law enforcement is an ineligible expense for Ground Operations Project. Applicant must remove the verbiage and costs associate with "public... OHV safety and regulations" and "user engagement". Applicant listed five (5) activities for this line item. Removing two (2) activities reduces the line-item total by 40%. Deduct \$15,635 from Grant and \$0 from match. Revised total for this line item is now Grant \$23,452 and match \$0.

- Staff # 3 "Park ranger Overtime" - Law enforcement is an ineligible expense for Ground Operations Project. Applicant must remove this line item. Deduct \$3,383 from Grant.
- Contracts #1 "Thomas Refuse" - Applicant increased the match request for this line item without receiving a Division or public comment. The line item reverts to the original preliminary Application match request of \$0. Deduct \$4,855 from match. The revised total for this line item is now Grant \$0 and match \$50,000.
