- Equipment Use Expenses #5–8 Contingent line item: The Applicant must describe in each of the note sections how each piece of Equipment will be used on the Project. In addition, The Applicant increased the match request for these combined line items without receiving a Division or public comment. Line items revert to the original preliminary Application match request of \$31,012 combined. Deduct \$79 from match. The revised total of these combined line items is now Grant \$0 and match \$31,012.
- Indirect Costs #1 "Indirect Costs 15% of Grant Request" The Applicant has now exceeded the 15% maximum allowable for Indirect. Deduct \$245 indirect match. The revised total for this line item is now Grant \$0 and match \$144,353.
- Staff #1 "Visitor Services Staff" The Applicant does not meet the minimum 26% match requirement for the Project. Move \$1,630 from Grant to match. The revised total for this line item is now Grant \$89,981 and match \$1,630.

Deduct 3 points.
- #8 The narrative does not support the selection. Each partner must actively
 participate in completing the Project. Each partner is working on their own
 individual projects that are not specifically related to this Project. Deduct 4 points.
- #10 The narrative does not support the selection. The "underlying problem that resulted in the need for the Restoration Project" has not been resolved, as illegal access is ongoing. Deduct 3 points.
- #11 The Project Description section does not support "1 10 acres within the Project Area" of sensitive habitats that will be actively restored within the Project Area. Monitoring and installing signs and barriers are not considered active Restoration activities, and it is unclear if any active Restoration techniques will be necessary until the G23 Restoration plan is completed. Deduct 3 points.
- #12 The narrative does not support selection. The Applicant did not provide information to support the current legal/illegal OHV Recreation occurring in the Project Area. Deduct 20 points.
