General Evaluation Criteria

- #1d - OHV Opportunity Ratio. Add 4 points.
- #6 - Applicant has been responsive. Add 3 points.
- #7b - Narrative does not support the selection. It is unclear whether the majority of the OHV opportunity areas are patrolled at least once per week. Deduct 3 points.
- #7c - Narrative does not support the selection of "Education programs, maps...". "Events throughout the year" and "Tread Lightly signage" are not considered education programs, maps, and/or brochures. In addition, Applicant did not provide a detailed explanation of whether the maps address OHV trespass, including respect for private property. Deduct 2 points.
- #11c - Narrative does not support the selection. "Up to seven days depending on staffing and availability," is not a guarantee that staff are onsite daily. Deduct 5 points.

- #3 - Project Description section and narrative do not support the selection of “Maintaining trail or road tread for single vehicle use” and “Providing varied levels of riding difficulty.” Applicant did not provide example(s) of Project activities being performed that support the selection. Deduct 2 points.
- #6 - Narrative does not support the selection of “Protecting water quality...”. Applicant did not provide examples of the activities performed in the Project that support the selection. Deduct 1 point.
- #8 - Background and/or Project Description sections do not support the selections. Applicant did not provide information that supports the selections. Applicant states non-motorized recreational opportunities within Alabama Hills National Scenic Area but did not clearly state if those opportunities are accessed by motorized use within the Project Area pertaining to trail maintenance (ground disturbing activities). Deduct 6 points.
