The Applicant received funds from four different Program Grants in FY23, with the totals as follows: \$138,914 for Law Enforcement, \$196,024 for Ground Operations, \$64,200 for Education and Safety, and \$285,387 for Restoration (the total amount of \$856,160 is divided by three, as it is a three–year Project). The combined total of these Projects exceeds 10% of the agency's program cost from the OHV trust fund. Deduct 3 points.
- #6 The Applicant has been responsive. Add 3 points.
- #11a The narrative does not support the selection. The Applicant did not provide additional information substantiating "safe" OHV practices. Deduct 5 points.
- #11b The narrative does not support the selection. Estimated events are not considered accurate onsite scheduled events. Deduct 1 point.
