The Applicant listed three (3) Project activities for this line item. Removing two (2) items reduces the line-item total by 67%. Deduct \$3,015 from Grant (could not move the cost to the Indirect

Costs category as Project is over the allowable 15% maximum indirect amount). The revised total for this line item is now Grant \$1,485 and match \$0.

• Indirect Costs #1 "Indirect Costs" – The Applicant has now exceeded the 15% allowable amount for Indirect. Deduct \$450 from match. The revised total for this line item is now Grant \$0 and match \$33,980.

- #7 The Project Description and/or Project Cost Estimate sections do not support the selections of "Barrier materials which include recycled..." and "Erosion control features which use..." are made with recycled materials. Deduct 2 points.

Deduct 6 points.

The Applicant listed five (5) items for this line item. Removing 1 (one) item reduces the line item by 20%. Deduct \$1,000 from Grant (could not move the cost to the Indirect Costs category as Project is over the allowable 15% maximum indirect amount). The revised total for this line item is now Grant \$4,000 and match \$0.
- Indirect Cost Category #1 "Indirect Costs" The Applicant has now exceeded the 15% maximum allowable for Indirect. Deduct \$150 match. The revised total for this line item is now Grant \$0.00 and match \$21,450.
