## **Evaluation Criteria**

- #3 – Applicant has been responsive. Add 3 points.
- #4 – The “Kern County Fire Department” is not supported within the Applicant's Project Background and/or Description. Deduct 1 point.
- #14 – Narrative does not support “Other”. This is duplicative of the points awarded in #12 “Level of Personnel Trained”, as EMTs are required to have the certification. Deduct 2 points.

### **Project Cost Estimate**

- Staff #5 "Full Time Park Aide/OHV Clerk" – Applicant clarified that "training seasonal park aides" does not entirely consist of on-the-job training. The Applicant must move the verbiage for this activity and its associated cost to the Indirect Cost category. The Applicant listed seven (7) items for this line item; by removing one (1) item, the line item total is reduced by 14%. Deduct \$8,791 from Grant. The revised total for this line item is now Grant \$54,004 and match \$0.

## **Evaluation Criteria**

- #3 – Narrative does not support the selection of "Providing varied levels of riding difficulty". Applicant did not provide examples of Project activities being performed that support the selection. Deduct 1 point.

- #5 – Narrative does not support the selection. It is unclear how Cal City MX Park, a privately owned facility, is in the Project Area. In addition, Applicant is reminded that Project Activities cannot occur on privately owned lands. Deduct 1 point.

### **Law Enforcement: G25-03-26-L01**

#### **Needs Assessment**

- Item #2 – Applicant is advised that patrolling for anything other than OHV Recreational activities is not eligible for Project activities as they do not have an OHV nexus.
  - For example, patrolling for the following is not eligible: illegal shooting, health and safety codes, municipal codes, penal codes, California Vehicle Codes not related to §38000, noise control not related to OHVs, trespassing.
  - The use of an OHV vehicle does not make it an OHV nexus.
