  adequately respond to the Division comment and provide clarification of what the
  Project activity of "Promotion" is and explain the needs for this activity. Applicant
  listed five (5) Project activities for this line item. Removing one (1) activity
  reduces the line-item total by 20%. Deduct \$9,050 Grant. The revised total for
  this line item is now Grant \$36,200 and match \$0.
- Others #1 "Hosting" This line item is considered indirect as it does not directly relate to the completion of the Project. The Applicant must deduct \$1,200 from Grant (could not move the cost to the Indirect Costs category as the Project is over the allowable 15% maximum indirect amount).
- Indirect Costs #1 "Admin" The Applicant has now exceeded the 15% maximum allowable. Deduct \$1,358 match. The revised total for this line item is now Grant \$4,000 and match \$442.

- #3 The Applicant has been responsive. Add 3 points.
- #5 The Project Description section does not support the selections of "ATV" and "Motorcycle". The Project is specifically for UTV users, and although other user types may indirectly benefit from UTV users being properly educated, those other OHV user types do not participate in the course, and the educational materials are not intended for them. Deduct 2 points.
- #7 The narrative does not support the selection of a "Testing process to ensure outcomes are effective". The Applicant did not provide clearly identifiable and/or measurable elements to substantiate the selection. Deduct 2 points.
- #8 The Project Description is unclear about whether "Formal class setting" and "Internet classes" are taking place. Formal classroom training must consist of a live instructor teaching a subject to the participant. In addition, an Internet class needs a live instructor; otherwise, a recording is audio/visual. Deduct 4 points.
