Project Description – List of Project Deliverables

- #1 – Applicant must specify the number of trail/road miles being groomed in the Project. Applicant stated "as needed" and it is unclear whether 15 miles of trail will be groomed.
- #4 – Applicant must clarify how “Install tire fill air station” is different from the previous year’s Application. This activity was also included in the previous year’s Application and is not supported by the Project Cost Estimate.

Project Description – All Others

- Equipment Use Expenses #1 & 2 – Applicant must clarify how the rental cost was determined.
- Equipment Use Expenses #2 “Dozer Rental” – Applicant must clarify how the Equipment will be used on the Project and why Grant purchased Equipment cannot be used on these Project activities.
- Equipment Purchase #1 "UTV" – It is unclear how an additional UTV is needed to achieve the Project Deliverables. Applicant must clarify the need to purchase UTV as Applicant already owns multiple UTV's as identified in known OLGA inventory.

- #3 – “The BLM also cooperates with the United States Coast Guard during beach related search and rescue”, Applicant is reminded only search and rescue activities with an OHV nexus are eligible under an OHV Law Enforcement Grant.
- #6 – Applicant must provide additional details identifying curriculum used to train personnel in natural and cultural resource protection.

Project Cost Estimate

- Staff #1 “Outdoor Recreation Planner” – Applicant must clarify how many regular hours vs overtime hours are expected for the position.
- Staff #3 “Park Ranger” – Applicant must clarify how many regular hours vs overtime hours are expected for the position.
