## **BLM PERSONNEL NEWS**

Jamie Fields' temporary assignment as the OHV and Travel Management Program Lead for the BLM California State Office has ended. Another temporary staff person is expected to start in the role in early November. The BLM is in the process of hiring for this position and anticipates having the role permanently filled by early 2024.

## **NEWS AND EVENTS**

BLM's El Centro Field Office staff are busy preparing for the upcoming visitation season for the Imperial Sand Dunes Recreation Area (ISDRA). El Centro Field Office will re-open the Cahuilla and Buttercup Ranger Stations in the Imperial Sand Dunes Recreation Area on October 14, after a hiatus for the hot summer months. The public will be able to obtain a variety of visitor services at the ranger stations, including maps and other information, first aid, and permits for the fee area, which are available for purchase. Overall visitation for the ISDRA from October through April is expected to be above average for the season with Halloween, Thanksgiving, New Years, and Presidents' Day, spiking up to 100,000 visitors in a week. Permits are required for most days between early-October and mid-April each year.

The Redding and Arcata field offices are accepting public comments through December 28 on the draft Northwest California Integrated Resource Management Plan and Environmental Impact Statement. The Plan will guide management of approximately 382,200 acres of public land and approximately 295,100 acres of subsurface minerals in Del Norte, Siskiyou, Shasta, Humboldt, Mendocino, Trinity, Tehama and Butte counties for the next 15 to 20 years. Included in the Plan are decisions about BLM-managed lands that would be open, closed, and limited to existing routes for OHV travel, specifically the potential designation of the Chappie-Shasta and Samoa Special Recreation Management Areas, which would have an emphasis on managing for OHV recreation opportunities. However, this Plan does not include route-by-route travel management OHV trail designations.

The BLM will host in-person public meetings on October 30 at the Bear River Community Center in Lolita, CA, and on November 2 at the Sheraton Hotel at the Sundial Bridge in Redding, CA. There is also a virtual public meeting on December 13. Each meeting will include an informational presentation and an open-house format in which participants can meet with BLM specialists to discuss the topics of interest. Plan development is also an agenda item at the Northern California District Resource Advisory Committee meeting on October 26 in Susanville. The meeting is open to the public, and a virtual attendance option is available through Zoom.

Storm damage from Hurricane Hilary and the historic winter storms in California have resulted in some temporary road closures and challenging road conditions on those that remain open. Access to the Alabama Hills National Scenic Area, managed by the Bishop Field Office, is affected.

Cal Trans has opened State Highway 127 from the Nevada border to Dumont Dunes Road. Thanks to a collaborative effort between Cal Trans and BLM, repairs along Dumont Dunes Road, leading into the Dumont Dunes OHV Recreation Area have been completed, allowing BLM to keep the dunes open to the public. Due to significant damage along State Highway 127, between Dumont Dunes Road and the community of Baker, the main access to Little Dumont Dunes and other BLM lands along State Highway 127 will remain closed until further notice.
