- Materials / Supplies #1 "Safety Supplies" "IFAK/First Aid Kits" are considered indirect as it does not directly relate to the completion of the Project. The Applicant must move them to the Indirect Costs category. Move \$1,500 to Grant Indirect Costs category. The revised total for this line item is now Grant \$6,000 and match \$0.
- Equipment Use Expenses # 8 "Equipment Rental Use Fee" This line item is ineligible. Per the Program regulations, trailers and command posts are not considered Equipment; therefore, they are not eligible for a use fee. The Applicant must remove this line item. Deduct 10,800 from match.
- Equipment Use Expenses # 9 "Equipment Rental Use Fee" This line item is ineligible. Per the Program regulations, trailers and command posts are not considered Equipment therefore, they are not eligible for a use fee. The Applicant must remove this line item. Deduct 6,000 from match.
- Equipment Purchases #1 "Current Model Jeep Gladiator Mojave" The Applicant did not respond to the Division's comment to justify the cost of the Equipment and the rationale and need for acquiring an additional piece of Equipment. Considering the Applicant already has five pieces of Equipment in their fleet to meet the Project deliverables and no further justification for the Equipment was provided, the Applicant must remove this line item. Deduct \$75,000 from Grant and \$0 from match.

- Equipment Purchases #2 " Honda Talon 1000X–4 Fox Live Valve ROV" The
 Applicant did not respond to the Division's comment to justify the cost of the
 Equipment and the rationale and need for acquiring an additional piece of
 Equipment. Considering the Applicant already has five pieces of Equipment in
 their fleet to meet the Project deliverables and no further justification for the
 Equipment was provided, the Applicant must remove this line item. Deduct
 \$35,000 from Grant and \$0 from match.
- Others #1 "Training" Only 50% of the Dual Sport school is related to OHV patrol. The Applicant may only apply 50% of the two–day P.O.S.T certified motorcycle class as it relates to OHV patrol. The Applicant must reduce the cost for this class by 50% Deduct \$3,500 from Grant. The revised total for this line item is now Grant \$16,500 and match \$0.
