Zachary Ormsby Serves As New Bureau of Land Management Central Coast Field Manager

December 21 / MARINA, Calif. – The Bureau of Land Management announces Zachary Ormsby as the new Central Coast Field Manager. have a dedicated staff that is committed to keeping public lands healthy, productive and accessible."


A native of Nevada, and a graduate of the University of San Diego, Ormsby began his career as a field-biologist in California where he spent more than ten years studying golden eagles and birds of prey. His published research focuses on the wildland-urban interface and he holds a Master's degree in Natural Resource Planning, Policy, and Law from the University of Nevada, Reno. He worked for the Walker River State Recreation Area, and later managed the statewide Conservation Districts Program where he worked with ranchers and agricultural producers to implement conservation strategies. Before joining the agency as a specialist for the National Conservation Lands and Community Partnerships Division at the Bureau of Land Management Headquarters, Ormsby coordinated with the BLM throughout his career.

As field manager, Ormsby will oversee management of public lands such as the Fort Ord National Monument, the Clear Creek Management Area and the Cotoni-Coast Dairies Unit of the California Coastal National Monument. The office manages public lands in Central California, including those closest to the San Francisco Bay Area, and oversees recreation areas, energy development and cultural

programs, as well as protection of threatened and endangered species. Ormsby succeeds Ben Blom, who has taken a position outside the agency.

"I am excited about the selection of Zachary as the next BLM Central Coast Field Manager," said Central California District Manager Chris Heppe. "He will bring a diverse range of experiences and collaborative leadership to the field manager position."

Ormsby grew up spending summers in Santa Cruz with family and enjoys any activity that allows him to be outside on public lands with his dog, Zoe. He is an avid snowboarder, hiker, birdwatcher and photographer who loves to cook and travel.

The Bureau of Land Management Welcomes New California Coastal National Monument Manager

February 3 / EL DORADO HILLS, Calif. – The Bureau of Land Management is pleased to announce Leisyka Parrott as the new Bureau of Land Management California Coastal National Monument manager. With nearly 20 years of public service, Leisyka brings a diversity of natural resource expertise to the position where she will oversee the management of approximately 20,000 offshore rocks and islands, and more than 7,900 acres of public lands in six onshore units along California's coastline.

"This spectacular coastal resource is an inspiration for Californians and visitors from around the world," said Central California District Manager Chris Heppe. "Leisyka is an experienced leader who brings a strong background in collaboration, cooperation and coordination needed to manage this important and complex resource."

A native of coastal California, and a graduate of Humboldt State University (Cal Poly Humboldt), Leisyka began her career in the northwest Great Basin as a fire lookout for the BLM fire program for eight years. In 2010, she joined the BLM Arcata Field Office as an interpretive specialist in the monument's gateway community of Trinidad, bringing interpretation, education and stewardship opportunities to the north coast and its watersheds. Working with local partners, she led the North Coast Seabird Protection Network which serves to reduce impacts on seabirds through monitoring populations, and public education programs. In her more recent role as assistant field manager in Ukiah, she worked with the Point Arena Gateway partners and led interdisciplinary resource staff in developing plans for trails, implementing fuel reduction work and completing watershed restoration.

"I look forward to collaborating with coastal Tribal governments, local communities, organizations and agency partners," said Leisyka. "We will work together to keep these iconic public lands healthy and accessible for generations to come."

The California Coastal National Monument provides important habitat for nesting seabirds and marine mammals. The six onshore units include Trinidad Head Lighthouse, Waluplh-Lighthouse Ranch, Lost Coast Headlands, Point Arena-Stornetta, Cotoni-Coast Dairies and Piedras Blancas Light Station.

Leisyka grew up on a 35' sailboat in the Santa Cruz Yacht Harbor. Homeschooled by her parents during the winter months, her family would sail to Baja and use the ocean and coastal ecosystems as a classroom. Leisyka's most recent international trip took her to the Santa Marta Mountains of Colombia to see the endemic Santa Marta Warbler. She enjoys adventuring with her son Izaak to visit family, soaking in hot springs, and bird watching with her partner Russ.



Melissa Hovey Named Monument Manager of Berryessa Snow Mountain National Monument

THE BLM PLANS PUBLIC SAFETY MEASURES FOR 2023 KING OF THE HAMMERS RACE



November 18 / PALM SPRINGS, Calif. — The Bureau of Land Management will implement a temporary closure of public lands from Feb. 2 – Feb. 12, 2023, in the Johnson Valley Off-Highway Vehicle Recreation Area, San Bernardino County, during the annual 2023 King of the Hammers desert race event. The race is authorized by a BLM Special Recreation Permit and the temporary closure is necessary to facilitate public safety and provide an enhanced recreation experience for event participants and spectators.

The BLM has <u>approved a five-year public land closure</u> for up to 10 days a year through 2027. Registered race spectators, participants and race officials are exempt from the closure. Approximately 81,000 acres of the Johnson Valley OHV Recreation Area will be temporarily closed to public use and approximately 46,000 acres will be available for public use during the event.

"The safety of spectators and participants is our top priority. The public is reminded to recreate responsibly and cooperate with race officials and local law enforcement officers to stay safe and ensure the success of the off-road races," said Michelle Lynch, BLM California Desert District Manager.

The temporary closure complies with the management plan for the area. A minimum of three staging areas within the Johnson Valley Off-Highway Vehicle Recreation Area will remain open to the public for both weekends of the temporary closure period. Nearby limited use areas will remain available for off-highway vehicle and other recreation uses. Information and a map of the closure area for the 2023 race event will be available for viewing at the BLM's California Desert District Office and the Barstow Field Office. BLM ACQUIRES LANDS FOR HABITAT CONSERVATION, RECREATION OPPORTUNTIES



January 19 / SUSANVILLE, Calif. – The Bureau of Land Management has acquired more than 800 acres of land in five areas of northern California and northwest Nevada to improve opportunities for wildlife habitat conservation and public access for recreation. These acquisitions from willing sellers were funded by the Land and Water Conservation Fund and state grants with the goal of conserving America's lands for the benefit of all people.

"These newly acquired lands in northern California will provide important public benefits now and into the future," said Karen Mouritsen, Bureau of Land Management California State Director. "These acquisitions help advance the "America the Beautiful" initiative and will provide increased opportunities for people to connect with their public lands."

In Lassen County, 680 acres along Upper Smoke Creek east of U.S. Highway 395 are now publicly owned, enhancing opportunities for the BLM and partners to maintain and improve critical habitat for greater sage-grouse, mule deer and other wildlife. This high desert land contains numerous springs that provide water year-round, along with miles of creek habitat and hundreds of acres of riparian areas and wetlands. The area northeast of Susanville is popular with hunters who pursue mule deer, antelope, and upland birds. The area is culturally significant to local Native American Tribes.

The BLM has also acquired 40 acres near the Biscar Wildlife Area on the west side of U.S. Highway 395 northeast of Susanville. The parcel includes a quarter mile of Snowstorm Creek and its associated riparian area, including a spring that flows year-round. The area is important habitat for raptors, owls, waterfowl, mule deer and greater sage grouse.

Closer to Susanville, the Reynolds parcel acquisition of 18 acres at the Rice Canyon Off-Highway Vehicle Recreation Area will enhance riding and off-road driving opportunities. The addition to this off-highway vehicle area provides an important buffer between the recreation area trailhead and adjacent private property owners.

In far northwest Nevada, the BLM has expanded access for public land hunting and dispersed camping with the acquisition of a 40-acre parcel at Divine Springs in the Hays Range about 30 miles east of Cedarville, Calif. The parcel is dotted with stands of mountain mahogany and western juniper and expanses of sage and bitterbrush, all providing important wildlife habitat.

In west Redding, the BLM has acquired 40 acres within the popular Swasey Recreation Area, allowing for expanded mountain biking and hiking trails. Swasey is one of the most visited recreation areas managed by the BLM in Redding, offering more than 30 miles of trails for riders and hikers of all abilities.

The Land and Water Conservation Fund was permanently authorized in 2019. In 2020, Congress passed the Great American Outdoors Act and enacted Land and Water Conservation Fund funding of \$900 million annually. Congress allocates this funding to the BLM, the National Park Service, the U.S. Fish and Wildlife Service, the U.S. Forest Service, and state and local governments.

NOHVCC LISTENING SESSIONS- SOUTHERN AREA SESSIONS ARE SCHEDULED FOR LATE-MARCH TO MID- APRIL, 2023



March 2023 — The Bureau of Land Management continues to work in partnership with the national non-profit organization National Off-Highway Vehicle Conservation Council (NOHVCC) www.nohvcc.org to gather public input and learn how the BLM can better provide access to high quality OHV recreation experiences throughout California. This public input will be compiled by NOHVCC into a State-wide OHV Action

Plan that BLM can use as an aide to help <u>guide</u> future OHV and travel management and resource management decisions.

This partnership with NOHVCC began nationally in 2014 and together a National Motorized Recreation Action Strategy was developed, which is designed to help the BLM develop individual State Action Plans for providing high quality OHV opportunities and developing partnerships to maintaing these opportunities.

So far, this process has created state-specific action plans in seven other states. NOHVCC is now working with the BLM to create a California statewide OHV Action Plan.

NOHVCC is the lead in this effort and in order to make this happen in California, they need your assistance and insights.

In developing these strategies, you as an enthusiast will have a chance to share your thoughts on the following topics:

- What activities are taking place on BLM-managed lands in California?
- Where in general are these OHV activities taking place?
- What experiences are you looking for on BLM-managed lands?
- Where might these missing activities fit on BLM-managed lands in California?
- What could the land managers do better to enhance your recreation experience?

To gather this important information, NOHVCC has already hosted one set of listening sessions, focused on the Northern CA areas in November 2022. They are now shifting focus to the southern California areas. These listening sessions will be entirely virtual and will occur late March to mid-April, 2023.

OFF-HIGHWAY VEHICLE (OHV) GRANTS



The BLM manages OHV areas to provide outstanding, sustainable opportunities for recreation on trails designed to minimize impacts on natural resources. The agency works closely with stakeholders and communities in this effort.

The public is invited to provide feedback to the BLM that will help identify new trails and redesign routes for better connectivity, find safer solutions for shared trails, provide greater public access, and offer a more enjoyable experience.

Public outreach meetings for the various field offices were held virtually and in-person in February to obtain public input on what grants to apply for and what to be included in the grants.

Field offices are diligently working on getting their preliminary applications completed by the March 6, 2023 deadline. Once the proposals are submitted to the Off-Highway Motor Vehicle Recreation (OHMVR) Division, they will be available on the OHMVR Division website for additional public review and comment from March 7 to May 1, 2023.

TREAD LIGHTLY! PARTNERSHIP AGREEMENT UPDATE



The Bureau of Land Management and Tread Lightly! California have been working together to promote responsible recreation to motorized recreationists as well as to highlight the 2023 California OHV Safety Weeks; they are working hard, in collaboration with the Safety Week Working Group, to finalize this year's theme and logo.

Tread Lightly! distributes education materials for the Bureau of Land Management field offices to distribute during community engagement events.

Tread Lightly! acts as a resource for land managers to utilize as extra hands to complete trail maintenance projects. Tread Lightly! can engage volunteers and fund smaller non-profit organizations and volunteer groups that clean up BLM areas through Tread Lightly's relationship with BFGoodrich Outstanding Trails.

Tread Lightly! has supported the BLM in the following projects since the last BLM Report in November 2022:

- November 5, 2022: Lost Lizard Fun Run/Cleanup BLM El Centro
 Tread Lightly! attended this event and provided educational outreach, connecting with an estimated 400 attendees, and having one on one interactions with 50 individuals.
- Ianuary 14, 2023: 25th Annual Imperial Sand Dunes Recreation Area Cleanup **BLM El Centro**Tread Lightly! helped run a remote volunteer station for the 25th Annual Imperial Dunes Recreation Area (ISDRA) cleanup. This year's event pulled 400 volunteers to the ISDRA who collected trash over a three-hour period at six distinct areas. Educational outreach was also performed via a booth setup within the Dunes.
- Jan 21, 2023: Yuha Well Historic Sign Reinstallation BLM El Centro
 Tread Lightly! has partnered with the Quadratec 50 for 50 initiative to fund a project committed to improve an off-road trails and public lands in each of the 50 states by December 2023. On January

21, 2023, Tread Lightly! hosted a small group of volunteers, including members of Rebelle Rally and Total Chaos, to reinstall a historic sign on the Juan Bautista De Anza National Historic Trail. This sign marks the Yuha Well, an important water source in the 1700s on the trail between Yuma and San Diego. The original sign had fallen into disrepair ten years ago and had completely disappeared from the site. The new sign, designed to emulate the historic style of the original, provides historical context to the Yuha Well site, and marks it as an area of historic significance once again. This was the fourteenth project of fifty as part of Quadratec and Tread Lightly!'s 50 for 50 initiative.

Tread Lightly! hosted daily cleanups at the popular spectator areas Chocolate Thunder and
Backdoor during the King of the Hammers off-road racing event, and set up multiple receptacle
stations at each site. These spectator areas collectively drew thousands of spectators each day. Over
the course of 8 days, 95 volunteers worked for 285 hours and collected 9,050 lbs. of trash.

FIRE NEWS: BLM CALIFORNIA SEASONAL FIRE RESTRICTIONS



Currently, there are no seasonal fire restrictions in place for any BLM California field office or district, however <u>statewide</u>, <u>year-round fire restriction</u>, issued in 2020 remains in effect through 2025. Under this order, the public is required to follow these criteria before building, attending, maintaining, or using a campfire, charcoal, coal, or wood stove outside of a developed campground:

 Maintain a five-foot diameter area cleared to bare soil and free of any overhead flammable materials in all directions around the

campfire;

- Have on hand a functioning round-point shovel with an overall length of at least 35 inches, that can be easily accessed within a reasonable amount of time in response to a fire ignition;
- Possess a valid California Campfire Permit, available free of charge: <u>Campfire Permit Ready for Wildfire</u>.
