- Staff #5 "OHV Field Manager GS-9 SGNM" – The Applicant removed "Public Outreach...at the OHV area entrance station" activities from the line item but did not reduce the line item total. The Applicant stated this activity is "2% of overall time" of the total line item activities, line item total is reduced by 2%. Deduct \$430 from Grant and \$151 from match. The revised total for this line item is now Grant \$10,890 and match \$17,569.

- Staff #6 "OHV Technician GS–5 SGNM"– The Applicant removed "Public Outreach...at the OHV area entrance station" activities from the line item but did not reduce the line item total. The Applicant stated this activity is "2% of overall time" of the total line item activities, line item total is reduced by 2%. Deduct \$475 from Grant. The revised total for this line item is now Grant \$23,285 and match \$0.
- Staff #7 "OHV Technician GS–7 SGNM" – The Applicant removed "Public Outreach...at the OHV area entrance station" activities from the line item but did not reduce the line item total. The Applicant stated this activity is "2% of overall time" of the total line item activities, line item total is reduced by 2%. Deduct \$581 from Grant and \$204 from match. The revised total for this line item is now Grant \$29,665 and match \$8,823.
- Indirect Costs #1 "Accounting, Billing,& Contract Admin" – The Applicant has now exceeded the 15% maximum allowable. Deduct \$223 from match. The revised total for this line item is now Grant \$0 and match \$56,797.
