Staff #4 "FMSAC Executive Director" – The Applicant removed "Financial record keeping", "marketing and promotion", "regular meetings with Forest Service staff" and "management of grant agreement between MSAC and USFS from the line item. The Applicant did not remove associated costs. The Applicant listed six (6) different types of Project activities. Removing four (4) activities reduces the line item by 67%. Deduct \$4,609 from Grant and \$4,798 from match. The revised total for this line item is now Grant \$3,181 and match \$1,452.
