The revised total for this line item is now Grant \$1,172 and \$0 match.

- Indirect Costs Applicant has now exceeded 15% of the allowable amount for Indirect. Deduct \$328 from Indirect Grant. In addition, the Applicant does not meet the minimum 26% match requirement for the Project. Move \$7,572 from Grant to match. The revised total for Indirect Costs category is now Grant \$56,164 and match \$80,572

 The Applicant stated RTF hosted the meeting, but to get credit for this selection,
 the Applicant must host the meeting. Deduct 1 point.
- #13 The Background and/or Project Description sections do not support the selection of "Runoff". The Applicant did not provide information on how the "Runoff" is addressed within this Project in the Background and/or Project Description sections. Deduct 1 point.
