VI. BUSINESS ITEMS <sup>(1)(2a)(2c)</sup>

- A. Election of Officers for 2011. The Commission shall elect a Chair and Vice Chair who shall serve for a one year term until his or her successor is elected. (PRC §5090.19)
- B. FY 2011/2012 Budget Update. The OHMVR Commission will be briefed and may comment or take other appropriate action on developments since the Commission's March 14, 2011, meeting pertaining to the OHMVR Program budget for FY 2011/2012.
- C. The Commission will be briefed and may comment or take other appropriate action on developments since the Commission's April 5 and 6, 2011, tour and meeting pertaining to the Clear Creek Management Area, managed by the BLM Hollister Field Office.
- D. The Commission will receive a briefing from the BLM on recent changes to the process and requirements for the issuance of Special Recreation Permits in the California Desert District Office. These changes include adjustments to the minimum fee for commercial, competitive and organized group activities or events on BLM lands.
- E. Pursuant to PRC §5090.24 (b), the Commission will collect public input so it may consider and make appropriate recommendations for program improvements and specific project needs for the system prior to the beginning of the 2011/2012 grant program cycle in order to meet the strict timeline for any regulatory changes.

- 1:00 p.m. F. Immediately following the lunch break, the Commission will consider, and may take action on, a presentation from the Marine Corps regarding the proposed expansion of the training range at Marine Corps Air Ground Combat Center, in Twentynine Palms. The Draft Environmental Impact Statement evaluates six proposed alternatives and the potential environmental impacts including expansion into the Johnson Valley OHV Area, managed by the BLM, Barstow Field Office.

- (1) Unless the order is revised by vote of the Commission, the Commission will proceed through the agenda in the order listed until the agenda is completed. Following consideration of those matters listed under Business Items the Commission may take action [Gov. Code §§11122, 11125 (a) and (b)]. The agenda will be interrupted at approximately 11:00 a.m. for public comment on topics not listed as business items on the Agenda.
- (2) PUBLIC COMMENT
  - (a) Agenda items (Green Public Comment form): The Chair will entertain public comment as agenda items are taken up by the Commission. Comments will be limited to two (2) minutes per individual or four (4) minutes for organizations. However, should there be more requests for comment than the scheduled meeting time will allow, at the discretion of the Chair, the time allocated per individual or per organizations may be reduced so as to allow public comment by all those who wish to speak. Those individuals wishing to comment on agenda items must fill out a green Public Comment Form titled, Agenda Items and submit it to the Commission recording secretary.
  - (b) Public Comment Period for All Non-Agenda Items (Blue Non-Agenda Item Comment form): Comments will be limited to two (2) minutes per individual or four (4) minutes for organizations. Those persons wishing to address the Commission on non-agenda items period must fill out the blue Public Comment form; the Non-Agenda Item Comment form and submit it to the Commission recording secretary.
  - (c) Written materials: Members of the public presenting written or graphic materials as part of their public comments to the Commission are requested to provide fourteen (14) copies to the recording secretary.
