DAY USE HOURS

In accordance with provisions of Section 4326 of Title 14, California Code of Regulations, for the protection of the health and safety of persons, property, and resources the lands and facilities of Capital district State Park units are hereby closed to public use, entry, and occupancy except as provided below. Daily Park hours are posted at major public use areas and entry gates.

Regular day use hours for Old Sacramento State Historic Park, the exterior grounds of Sutter's Fort State Historic Park, the California State Indian Museum as bordered by "K" Street on the north, 26th Street on the west, "L" Street on the south, and 28th Street on the east, and the California Indian Heritage Center property located in West Sacramento are:

- SUNRISE TO SUNSET seven days a week, year round

Regular day use hours for Sutter's Fort State Historic Park buildings and interior grounds (2701 "L" Street, Sacramento, CA), the California State Indian Museum interior facilities (2618 "K" Street Sacramento, CA), and the exterior grounds and interior facilities of the Leland Stanford Mansion State Historic Park (800 "N" Street, Sacramento, CA), and the interior facilities of the California State Railroad Museum (125 1 Street, Sacramento, CA) are:

- 10:00 A.M. TO 5:00 P.M seven days a week year-round except New Year's Day, Thanksgiving Day, and Christmas Day.

Capital District grounds and buildings may be excepted from this order as clearly posted on entrances or boundaries.

Exceptions to this order may be granted in writing by the District Superintendent or designee, Capital District, 101 "J" Street, Sacramento, CA 95814.

OPEN ALCOHOLIC BEVERAGE CONTAINER PROHIBITION

In accordance with provisions of Section 4326 of Title 14, California Code of Regulations, for the protection of the health and safety of persons, property, and resources in California State Parks Capital District the possession of open alcoholic beverage containers is hereby prohibited. This policy is effective in all day use areas and closed areas of the Capital District to include Old Sacramento State Historic Park including the Sacramento River Parkway, the Riverfront Beach Area, the California State Railroad Museum, Leland Stanford Mansion State Historic Park, Sutter's Fort State Historic Park, the California State Indian Museum, and the California Indian Heritage Center property located in West Sacramento.

"Alcoholic beverage" means any alcohol, spirits, wine, beer and every liquid or solid containing alcohol, spirits, wine, or beer.

"Open Container" means a bottle, can, or other receptacle, containing an alcoholic beverage which has been opened, or a seal broken, or the contents of which have been partially removed.

GLASS CONTAINER PROHIBITION

In accordance with provisions of Section 4326 of Title 14, California Code of Regulations, for the protection of the health and safety of the visiting public, due to the serious hazard created by discarded and/or broken glass, possession of glass containers is hereby prohibited in the following areas within the Capital District:

- In the area within 150' of the Sacramento River shoreline within the State Park boundary of Old Sacramento SHP.
- California Indian Heritage Center Property, West Sacramento.

The prohibition includes any glass bottle, tumbler, or vessel of any nature, empty or not, except that persons may pick up glass containers left or discarded by others and remove or deposit same in an approved trash or recycling receptacle.

SMOKING PROHIBITION

In accordance with provisions of Section 4326 of Title 14, California Code of Regulations, for the protection of the health and safety of persons, property, and resources; consistent with Section 5008.10 the California Public Resources Code, smoking and vaping is prohibited within all of the units of the Capital District to include: Old Sacramento State Historic Park including the Sacramento River Parkway, the Riverfront Beach Area, the California State Railroad Museum, Leland Stanford Mansion State Historic Park, Sutter's Fort State Historic Park, the California State Indian Museum and the California Indian Heritage Center property located in West Sacramento.

CLOSED/PROHIBITED AREAS

In accordance with the provisions of Section 4326 of Title 14, California Code of Regulations, for the Protection of the health and safety of persons, property and resources, locations within the Capital District are hereby closed to the public. Closed Areas are defined as:

Generally:

- Areas completely surrounded by a barrier, including, but not limited to fencing, wire, gates, walls, or other permanent or temporary device(s) limiting access to the general public.
- Areas clearly posted with official signage or temporarily marked by caution tape, cones, or barricades by agents of this Department or other authorized entity.
- Within facilities that have closed or locked doors, not generally open to the public.

Specific areas within Riverfront Park:

- Northern closed area bordered by the "I" Street Bridge to the North, Sacramento River to the west, Retaining wall on the west side of the Sacramento River Multi-Use Recreation Trail to the east and Latitude 38.584949 to the south.
- Southern closed area bordered by Latitude 38.584128 to the north, Sacramento River to the west, Retaining wall located along the Longitude -121.505953 to the east and "J" Street Dock to the south.

STORAGE OF PERSONAL PROPERTY PROHIBITED

In accordance with provisions of Section 4326 of title 14, California Code of Regulations, for the protection of the health and safety of persons, property, and resources within the lands and facilities of Capital District State Park Units it is unlawful and a public nuisance for any person to store, or leave unattended, any personal property including camp paraphernalia, carts, or luggage.

"Store" means to put aside or accumulate for use when needed, to put for safekeeping, to place or leave in any location unattended.

Per California Civil Code § 2080.1 and § 2080.7 respectively, personal property stored on or in Capital District lands or facilities will be immediately removed and stored by State Park Peace Officers as found or abandoned property. If unclaimed after ninety days, the property will be disposed of per those sections.

CAMPING PROHIBITED

In accordance with provisions of Section 4326 of title 14, California Code of Regulations, for the protection of the health and safety of persons, property, and resources within the lands and facilities of Capital District State Park Units it is unlawful and a public nuisance for any person to camp on the grounds of any Capital District unit.

Definitions:

Per California Code of Regulation Title 14 4301 (u) camping is defined as "Erecting a tent, shelter, or arranging bedding or both for the purposes of, or in such a way as will permit, remaining overnight."

Per CCR T14 4451 (a) No person shall camp, as defined in Section 4301 (u), in any unit except in areas provided for that purpose.

Capital District Camping Prohibitions:

- (a) No unit or portion of any unit within the Capital District is available for camping at any time.
- (b) No person shall erect a tent or shelter in any Capital District unit without the consent of the District Superintendent or designee.
- (c) Shade structures shall be open on all sides with clear visibility through the structure from all points of view.
- (d) No person shall place a mattress, foam pad, bed, camp bed, hammock or any sleeping structure on Capital District grounds.

PERSONAL CONVEYANCE DEVICE USE AND PARKING

In accordance with provisions of Section 4326 of Title 14, California Code of Regulations, for the protection of the health and safety of persons, property, and resources within the lands and facilities of Capital District State Park Units regulations for the use and parking are hereby established:

Definitions:

A "Personal Conveyance Device" (PCD) for the purposes of this order is defined as a device intended for transportation of one's person or property, with one or more wheels, operated by human propulsion or completely or partially assisted by an electric or gasoline motor. A PCD does not include a manually operated or power-driven device designed primarily for use by an individual with a mobility disability or a child, that is actively being used for the aid of a child or person with a mobility disability.

Capital District Personal Conveyance Device Regulations:

- (a) No person shall take a PCD into a Capital District lavatory.
- (b) No person shall park a PCD or towed object on any walkway or boardwalk, as to adversely affect safe or normal passage.
- (c) PCD's improperly parked may be removed and stored by Capital District State Park Peace Officers by cutting and removing a locking device, when necessary, per CCC § 2080.1 and 2080.7 respectively.
- (d) PCD's parked on disability access ramps will be removed and stored as above by Capital District State Park Peace Officers or designees.
- (e) No person shall ride a PCD on a boardwalk. All PCD's will be dismounted and walked through these areas; pedestrians have the right of way on boardwalks and walkways.
- (f) Per CCR T 14 4326(a) 670-24-009 the parking lot of the California State Railroad Museum at 125 I Street in Old Sacramento State Historic Park is closed to all persons except authorized personnel. No person shall ride a PCD through said parking lot.
- (g) No vehicle subject to registration under § 4000 or listed under § 38006 of the California Vehicle Code may be operated or left standing within any unit of the Capital District without authorization from the Department on official business. This section does not apply to permitted vehicles in Capital District designated off-street parking facilities.

AUTHORIZED PERSONNEL ONLY

In accordance with provisions of Section 4326 of Title 14, California Code of Regulations, for the protection of the health and safety of persons, property and resources parts of Old Sacramento State Historic Park are hereby closed to the public and identified as areas for Authorized Personnel Only.

Closed Areas are defined as:

1. California State Railroad Museum (CSRM) Parking lot:
 - Starting at the automatic east entry gate continuing west and south around to the railway turntable located on the east side of 125 "I" Street, Sacramento, CA 95814
2. Sacramento Southern Railroad (SSRR):
 - Area within fencing to the west of the CSRM including the turntable.
 - Any railroad tracks or right of way that starts in Old Sacramento and runs south to the gate across the tracks located 335 feet south of the railroad crossing at South Land Park Drive.
 - Any railroad tracks running south from the railroad crossing at the south side of Meadowview/ Pocket Road and continuing to the north edge of the roadway at Hood/Franklin Road in Hood, CA that is not at an authorized vehicle or pedestrian crossing.

USE OF STATE ELECTRICAL UTILITIES

In accordance with provisions of Section 4326 of Title 14, California Code of Regulations, for the protection of the health and safety of persons, property, and resources in California State Parks Capital District units, electric utilities and electrical outlets located within Capital District State Park units are to be utilized for official business of the Department unless specifically authorized for other use by agents of the Department. This policy is effective in all Capital District buildings and their surrounding grounds, including but not limited to the California State Railroad Museum, Leland Stanford Mansion State Historic Park, Sutter's Fort State Historic Park, the California State Indian Museum, and the California Indian Heritage Center property in West Sacramento.

No person without authorization shall utilize the electrical utilities or outlets to power any device or equipment. Any accessible outlets are in place for the sole use of State Parks staff or those directly authorized by State Parks staff during their official duties.

SANITARY USE OF RESTROOM FACILITIES

In accordance with provisions of Section 4326 of Title 14, California Code of Regulations, for the protection of the health and safety of persons, property, and resources in California State Parks Capital District units, unsanitary use of restroom facilities within the District is prohibited.

Unsanitary use of a restroom facility is defined as any of the following:

- Intentional damage or incapacitation of restroom facilities or equipment.
- Limiting public use of a space due to placement of personal property or excessive duration of occupancy.
- Excessive and inappropriate use of provided restroom sanitary supplies.
- Deposition of human waste, toilet paper, or provided sanitary paper seat covers in anything other than a toilet or urinal.

This policy shall be applicable to all units within the Capital District, including but not limited to: the California State Railroad Museum, Leland Stanford Mansion State Historic Park, Sutter's Fort State Historic Park, the California State Indian Museum, and the California Indian Heritage Center property in West Sacramento.

WHEELED MOBILITY DEVICE RESTRICTIONS

In accordance with provisions of Section 4326 of Title 14, California Code of Regulations, for the protection of the health and safety of persons, property, and resources in California State Parks Capital District units, devices powered by human, electric, gasoline propulsion, or combination thereof, are restricted in the following manners and areas within Capital District park units:

- Devices are restricted as regulated by any other applicable law, code, posting, or ordinance.
- Devices are restricted to 7 miles per hour maximum where operation is allowed, except along the Class I bike path paralleling the Sacramento River within Old Sacramento SHP where operation at a safe speed is allowed.
- Class I and II electric bicycles as defined per §312.5 of the California Vehicle Code are allowed in areas generally available and open to other personal conveyance devices (ref. Orders No. 670-24-005, 670-24-008, 670-24-009)
- Class III electric bicycles are not permitted to be operated within the Capital District.
- Devices improperly parked, vandalized, incapacitated, or otherwise posing a public hazard may be removed and stored by Capital District State Park Peace Officers by cutting and removing a locking device when necessary.
- Shared rideable devices permitted and otherwise regulated by the City of Sacramento and the City of West Sacramento are subject to the following restrictions:
 - Devices, operators, and owners shall follow any applicable, concurrent state laws or city codes while on State Park property.
 - Devices may not be left or parked when not in use on State Park property except in a public bike rack.
 - Devices shall be electronically restricted by the managing operator upon electronic written request by the Department. Restrictions may include but are not limited to maximum allowed speed, geofencing restricted areas, and ride start/stop areas.
 - Generally restricted areas are defined in two categories and indicated on Attachment A:
 - Restricted operation zones (Red)
 - No device operation is permitted.
 - No device trips may begin or end.
 - Limited operation zones (Yellow)
 - Device speed shall be electronically limited to 7 MPH maximum as capable.
 - No Device trips may begin or end.

This policy shall be applicable to all units within the Capital District, including but not limited to the California State Railroad Museum, Leland Stanford Mansion State Historic Park, Sutter's Fort State Historic Park, the California State Indian Museum, and the California Indian Heritage Center property in West Sacramento.

Exceptions to this order may be granted in writing by the District Superintendent or designee, Capital District, 101 J Street, Sacramento, CA 95814.


