Prior to issuance of a Funding Agreement, another resolution will be required which:

- 1. authorizes an officer to sign the Funding Agreement, certifications, and any amendments;
- 2. designates a person to approve claims for reimbursement;
- 3. designates a person to sign the "Funding Request and Project Status" form;
- 4. designates a person to sign the Certification of Project Completion (for a construction project), and
- 5. designates a person to sign the Final Release form.

If a loan is provided, the resolution will need to include:

- 1. the dedicated source of revenue
- 2. specific revenue stream to repay said loan and that
- 3. that the dedication of said source of revenue shall remain in full force and effect until the loan is fully discharged.

In addition, the resolution resolves that if for any reason, the source of revenue proves insufficient to satisfy the debt service, sufficient funds shall be raised through increased launching/parking rates, user charges, assessments or any other legal means available to meet the loan obligation and to operate and maintain the Project.
