### JULY 1, 2025

- 1. Curfew for JUVENILES (Juvenile is defined as a person under 18 years of age) is declared at Ocotillo Wells SVRA, Salton Sea SRA, Indio Hills Palms Property, Picacho SRA, and Heber Dunes SVRA from 10:00 PM until 6:00 AM daily, for the safety and welfare of the public:
  - A. No JUVENILE shall, during the effective period, enter or remain in Ocotillo Wells SVRA, Salton Sea SRA, Indio Hills Palms Property, Picacho SRA, and Heber Dunes SVRA, except as follows:
    - a. A Juvenile physically accompanied by a parent or guardian.
    - b. A Juvenile who is part of a group permitted to occupy a camping area and whom at least one responsible parent or guardian supervises.
    - c. A Juvenile who is lawfully camping, having furnished to the Department written consent of and the full name, residence number, and telephone number of the juvenile's parent or guardian, with the inclusive dates for which permission is granted to camp at the involved unit and that the written consent was received prior to the camping having occurred.
- 2. Exceptions to this order may be granted in writing by the District Superintendent, Ocotillo Wells District, 5172 HWY 78 #10, Borrego Springs, CA 92004.
- 3. Nothing herein shall affect any existing private contract or property rights.
- 4. Nothing herein shall be construed in derogation of other provisions of law.
